During the next few years (and thereafter), as part of The American Legion's strategy for continuous growth, we will have to concentrate much more on marketing our name and what we do than we've ever had to in the past. Thousands of "veterans' service organizations" have popped up all across the country. All are competing for the membership of veterans and the donations to help support their good works. Some do great things in a niche market. Some raise millions of dollars to support their programs. Some may actually do very little.

None do as much for active-duty military,

Part of every company's identity is its veterans, military retirees and their families as does The American Legion. And yet, we have no consistent tagline that readily tells people who we are, what we do or who we do it for. Each National Commander has a slogan and they are well thought out and well themed, but they don't lend a permanent identity to the Legion.

> Through the years we have had many slogans, including "Marching Together Again"; "Veterans Serving Veterans"; "Every Day is Veterans Day"; "Still Serving America"; and "For God and Country", which will never go away but doesn't serve as an effective tagline.

> The Membership and Post Activities Committee will meet in January to draft a strategic plan for growing membership year after year, and for inculcating into our corporate culture the idea that "growth is a prerequisite to everything we do."

> Another of the committee's tasks is to suggest a corporate tagline, which

– upon NEC approval – will be used for the foreseeable future in all of our advertisements, letterheads, publications, press releases and so forth as a description of who we are and what we do.

The goal is to adopt a tagline which is so significant that all of the public will recognize it, associate it with The American Legion and know what is our "reason for being." Even though it must be short and pithy, it must be filled with content and phrased in a memorable and catchy way.

You can help us craft an American Legion tagline by submitting your ideas by email. Submissions may be submitted by individuals (membership is not required), Posts, Districts, counties or Departments; there is no limit to the number that may be submitted, but each submission must be contained in a single email. is that of Alicia, a homeless, helpless and hopeless veteran who, after going through Monty Roberts' "Join-Up" workshop for veterans, went from living under bridges to earning a scholarship to Harvard where she is studying today to become a psychologist. (See her story at www.MontyRoberts.com)

Terry Tracy, former Marine and Past Dept. of California Service Officer and one of the most knowledgeable people in the state and nation on VA affairs and rehabilitation, said he went to the "Horse Sense & Soldiers" workshop in December extremely skeptical, but "left convinced that Monty Robert's 'join-up' method really does work and is an effective way to help veterans overcome debilitating stress, including PTSD."

Similarly, Jim Banakus, Chairman of the California American Legion Riders Commission, and a personal friend of Monty Roberts, said, "I have seen remarkable progress in the lives of those who have attended several sessions. Even after their first three-day clinic, you can see them starting to come out of the shell they arrived with on Friday morning, to one of learning to trust in themselves again by Sunday afternoon." Legends from other fields are expected to attend the March 22-24 workshop.

One is Matt Lindland, Mixed Martial Arts legend as fighter and coach, former Olympic Silver Medalist in Greco-Roman Wrestling, a founder of the world renown MMA training center Team Quest in Gresham, Oregon and the present Head Coach of the U.S. World [Olympic] Greco Roman Wrestling Team.

Lindland, an MMA great who has done a great deal of volunteer work with troops and veterans, including teaching hand-tohand combat, said: "I grew up in Eagle Creek in rural Oregon. Monty Roberts was one of my heroes. I think I read all of his books. I am really looking forward to working with Monty Roberts and the veterans at the 'Horse Sense & Soldiers' workshop, along with my daughter, Robin.'

Another is Christi Edelbrock, she of the family whose "Edelbrock" brand name is legendary in the world of hot rodders and high performance cars needing high performance parts. She is an equestrian who has performed at the Olympic level; is an industry leader at Edelbrock; has her own Christi Edelbrock Foundation doing charitable work; and among other things, will be staging her annual Edelbrock "Rev'ved Up For Kids" car show and fundraiser on May 5, 2013, in Torrance, California. "For as long as I have been involved in the equestrian world, competing professionally, I've never seen the kind of professionalism that Monty Roberts consistently demonstrates. What he is contributing to support veterans to overcome stress is nothing less than outstanding," said Christi Edelbrock, who is also the national spokeswoman for Patriot Outreach.

Monty Roberts' remarkable life has been the subject of movies, television documentaries, books, articles and countless media interviews. His autobiography, The Man Who Listens to Horses, has sold over 6.5 million copies worldwide in fifteen languages. Altogether, some 10 million of his books have been sold. Yet he remains a man on a mission in his humanitarian work, traveling all over the world more than 300 days a year to teach his "Join-Up" method to gentle horses without violence and to heal veterans, abused and autistic children, battered women and others who have suffered traumatic stress injury. I asked him, "Why does he continue to do it at age 77?" He answered, "Since the late 1940s I have stated that my life's goal is 'to leave the world a better place for horses and for people, too." Veterans returning from combat are not just people but, 'special people'. These are individuals who deserve our assistance if there's

For all he has contributed to the lives of veterans, The American Legion Department of California Executive Committee will have before it at its meeting March 8-10, 2013, a resolution from District 21 calling for Monty Roberts to be honored at the 2013 California Dept. Posts to give this information the widest dissemination, as we will do in your national publications. All submissions must be received no later than April 19, 2013, in order to be considered.

The Internal Affairs Commission will be the final reviewer of submissions and will draft a resolution recommending a permanent tagline. The decision of the National Executive Committee is final.

If your tagline is the one recommended to the NEC, and adopted exactly as submitted, you will receive a \$500 check, and a certificate of appreciation plaque signed by the National Commander in recognition of your winning entry. The winning entry will be posted on the Legion website after the NEC meets in mid-May 2013. In the event of duplicate winning entries, the earliest received will be declared the winner.

Remember: April 19, 2013 is the deadline, and the email address is tagline@legion.org. Please include your name and phone number on each entry. Only one entry per email submission. All entries will be acknowledged by a return email. Save that return receipt as proof of your submission.

# DoD and VA to scrap electronic health record program

WASHINGTON - The departments of Defense and Veterans Affairs are scrapping their joint effort to create an Integrated Electronic Health Record (iEHR) system by 2017, after spending about \$1 billion on the project.

Department of Veterans Affairs (VA) Secretary Eric Shinseki and Department of Defense (DoD) Secretary Leon Panetta made the announcement February 5 at VA's Central Office here.

The iEHR was previously lauded by VA and DoD as a solution to the ongoing problem of incompatibility between the two departments' electronic health record systems (VA's VISTA and DoD's ALTA).

"We applaud both secretaries for their efforts in trying to develop a truly seamless solution to this problem," said James E. Koutz, National Commander of The American Legion. "But our veterans are the real losers in this decision. Without a joint DoD-VA record that is easy to access, veterans have to ask for copies, and those requests often take months to process."

"We understand the financial constraints that both departments are under." Koutz said. "We're cautiously optimistic about the new plan and eagerly wait to hear more details."

ROSTER 2012-13 CHANGES: If you see in the Department Roster that your address and/or telephone number is wrong, please let me know ASAP. I am making up a "Roster Correction List" to

IRS AGAIN: A law still requires small American Legion Posts – those with annual gross receipts of \$50,000.00 or less to electronically file Form 990-N (e-Postcard) with the Internal Revenue Service each year. If those Posts do not file the form or a regular Form 990, they face losing their Tax-Exempt Status. So for American Legion Posts, the words "may be required to file" can be exchanged for "MUST file."

The same law means that all American Legion Posts must have their own unique Employer Identification Numbers, even if they have never filed one in years. A Post cannot use the EIN of its department or national headquarters. If it does, AGAIN, it risks losing its tax-exempt status.

The State of California has changed their law starting with the Tax Filing for 2012 and starting with the year 2013. It has <u>increased</u> the annual gross receipts to \$50,000.00 or less instead of the \$25,000.00 limit they have used up until

now. The electronic file form FTB 199-N (California e-Postcard) must be filed with the California Franchise Tax Board or the Form 199 if the Post's Annual Gross Receipts are OVER \$50,000.00.

ADJUTANT'S CORNER

REMEMBER: The Federal e-Postcard is Form 990-N. The California e-Postcard is FTB 199-N.

REMINDER: The American Legion "Officers Guide and Manual of Ceremonies" is your guide to The American Legion. It also contains the National Constitution and Bylaws of The American Legion, Membership Qualifications, How to run a Post meeting and many more useful things that have to do with The American Legion.

The "Officers Guide and Manual of Ceremonies" has already been sent to all Posts in the Department of California, along with a Department Roster and "Post Service Officers Guide".

If you go on the Internet to the National Website: www.legion.org and to the Department Website: www.calegion.org you will find a lot of manuals, brochures and forms that can be downloaded at no cost to you. Take some time and explore these two websites. You will be glad that you did explore the websites.

do not know how much that is going to mean to us who are going abroad. You do not know how much that means to any soldier who is over there carrying the flag for his country. That is the point which should be uppermost in the minds of those who are working for the soldier." In our Nation's populace today, are those words true today as they were spoken in WWI? Generally within the confines of Veterans, Patriotic Organizations and at the very heart of those who individually serve the Veterans Administration. However, how are we, as a nation of citizens, remembering our military and veterans?

The need of our veterans is great and yes, greater than the resources rationed by our government. The backlog of veteran's claims has increased as the conflicts in the Middle East continue to groan on and on. Many of our military, active, reserve and guardsmen, have served multiple deployments, and as the state of our world shows will probably deploy again and again. That means we, as an organization, will need to find the resources to meet this challenge. Just as our government, The American Legion has limited resources, which will constantly need resupplying as we care for those who have borne the battle, as well as their dependents. Those of us who serve our veterans as "Affiliates of the Veterans

Administration" will have job security based upon the abundant amount of work coming into our offices. However, without adequate funding we will be limited in what we can do for our present veterans, as well as our future veterans.

Rehabilitation programs in The American Legion have always been a viable asset, by helping veterans with claims and advocacy of veterans' rights. The Department of California sponsors the Rehab Fund Drive for the purpose of offsetting expenses incurred in the operation of the Veterans Affairs & Rehabilitation (VA&R) division. VA&R consists of thirteen full time employees staffing the three offices. These offices are colocated with Department of Veterans Affairs (VA) regional offices. VA&R also supports a part-time staff at almost every VA medical center and outpatient clinic in California. The mission of the staff is to make veteran's lives easier by providing expert, no-cost representation in VA claims to veterans, their dependents or survivors. But operational costs for the VA&R Division continue to increase, and we've had a serious shortfall for several years. In 2012, the Rehab Fund Drive raised \$221,572.09 of net income. Unfortunately, we were short on our fund drive net income in 2012 by about \$12,900. We are asking all of you to make sure this isn't a trend and bring in the best year ever in 2013. These necessary funds offset the VA&R budget of \$948,678. We'd like to have the full amount raised this year to cover the operating costs and hire the help we need. **EVERY DOLLAR DONATED TO THE REHAB FUND** DRIVE IS APPLIED TO REHAB. IT **DOES NOT GO IN THE DEPART-**MENT GENERAL FUND OR ANY **OTHER FUND!**

#### **DEPARTMENT CHAPLAIN**

"Freedom OF Religion", not "Freedom FROM Religion". This statement pretty much sums up the current situation facing the free expression of religion in America today. Religion has always been a part of American life.

The Pilgrims came to America seeking to practice their faith without being persecuted, harassed or denied their faith beliefs. Others followed later looking for new opportunities and freedom from the turbulent times of the seventeenth and eighteenth centuries. The writings of our Founding Fathers show that religion and faith were a part of their everyday lives.

General George Washington asked the Continental Congress to authorize the position of chaplain for the Continental Army so that he could have an ordained minister attend to the morale and wellbeing of the his troops as they endured many hardships, from bitter cold winters to being unable to return home to harvest crops.

When the Constitution of the United States was ratified, there was a call for amendments to address issues not clarified in the Constitution. Thus ten amendments were approved and added to the Constitution to address delegates' concerns. We know them as the "Bill of Rights". Amendment 1 reads: "Amendment 1 – Congress shall make no law respecting an establishment of religion or prohibiting the

free exercise thereof (emphasis added); or abridging the freedom of speech or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

After World War II, the world was beset by Communism. Communism stated that religion was false and suppressed in communist countries. Our response was to add "under God" to our Pledge of Allegiance to counter the godlessness of Communist propaganda. Families went to synagogue on Saturdays and to church on Sundays. We were taught that the United States of America was a democratic republic, governed by elected representatives and that the majority ruled.

Yet, starting in the latter part of the twentieth century, challenges to religious expression have mounted to where today, individuals and minority groups, through the courts, have repeatedly tried to remove any mention of God or religion from our daily lives. "In God We Trust" on coins, "under God" in the Pledge of Allegiance, no public expression of religion of any kind lest we offend someone (being "politically correct"). This is not the America I grew up in and remember.

Wherever we go we should always express our religious faith and ideals. Invocations and benedictions at public meetings, grace before and after meals, praying for our country, leaders, troops, veterans and families, whenever and wherever we gather together. This is part of our American heritage and why we say in The American Legion "For God and Country".

To give you an idea of what comprised some of division's workload in the calendar year 2012, Rehab filed 23,871 claims with the VA; represented claimants in 152 hearings before the local VA hearing boards and the traveling Board of Veterans Appeals (BVA); wrote briefs for 218 BVA appeals, reviewed 17,113 rating board decisions, and executed 40,383 other claim reviews or actions in conjunction with active VA claims. We had phone and personal interviews with 41,457 veterans, their dependents or representatives during 2012. Total correspondence received at the Rehab division's offices for review, action or distribution in 2012 exceeded 212,655. All in all, our efforts resulted in getting millions of dollars (January 1, 2012-December 31, 2012 = \$723.1 million) in benefits for veterans and their dependents. This is an increase in awards of \$59.2 million over 2011.

The purpose of the *Rehab Fund* **Drive** is to offset the operation of the Veterans Affairs & Rehabilitation (VA&R) division of the Department of California. The VA&R division is made up of three offices, located in Oakland, San Diego and Los Angeles. The primary purpose of the VA&R offices is to serve veterans and their dependents by providing no cost representation in US Department of Veterans Affairs (VAs) wide variety of benefits, including disability compensation, education, pension, survivor and home loan benefits. As a result of a new tracking system the VA&R division has realized (conservatively) from January 1, 2012 through December 31, 2012 over **\$723.4 million** in revenues for California veterans and their families. This is an increase over last year of \$59.1 million for calendar year 2011. This is due to legislative changes in Title 38, as well as a downturned economy concerning the benefits for veterans.

Without this kind of support, the VA & R Division could not assist our many veterans in our communities. This is not the only avenue you can take to assist our veterans. Do not forget we have the VA&R Foundation, which gives a tax benefit to corporations and businesses as a 501(3)(c). This gives our business community the chance to have a tax deduction by donating to our veterans in need. President John F. Kennedy once said, "As we express our gratitude, we must never forget that the highest appreciation (of our veterans) is not to utter words, but to live by them." Living by them means you can translate this by your financial support. To assist in this endeavor, won't you donate today?

### **DEPARTMENT PARLIAMENTARIAN** When the Chair Affects the Outcome of a Vote

If the presiding officer (the Chair) is a member of the assembly, he can vote as any other member when the vote is by ballot. In all other cases the Chair, if a member of the assembly, can (but is not obliged to) vote whenever his vote will

affect the outcome - that is, he can vote either to break or to cause a tie; or, in a case where a two-thirds vote is required, he can vote either to cause or to block the attainment of the necessary two-thirds. In particular, if a motion requires a simple majority and the vote is tied, the motion fails, since a tie is not a majority. In this case, the Chair can vote in the affirmative, break the tie and the motion

will pass. If the affirmative votes exceed the negative votes by one, the Chair could vote in the negative, thereby creating a tie and defeating the motion. The vote of the Chair can perform a similar function in a case where a two-thirds majority is required.

In an appeal from the decision of the Chair, a tie vote would sustain the chair, even if the Chair created the tie, because a majority is required to overrule the Chair and, as previously stated, a tie is not a majority.

It is important to note that the Chair cannot vote twice; once as a member, then again as the presiding officer. Also, the Chair, if a member of the assembly, can always vote in the case of a ballot vote at the time other members do. But should he fail to vote before the polls close, he cannot then do so without the permission of the assembly.

# Former Californian gets Medal of Honor for valor in Afghanistan

A former Californian was awarded the nation's highest military honor on Monday for his efforts against a 2009 Taliban attack on his Afghanistan outpost that U.S. officials have described as tactically indefensible.

Former Staff Sgt. Clinton Romesha, 31, received the Medal of Honor from President Obama during a nationally televised ceremony Monday (Feb. 11, 2013). Romesha is the fourth living recipient who fought in Iraq or Afghanistan. Seven others who fought in those conflicts have received the medal posthumously.

Romesha grew up in Lake City in Northern California, near the Oregon border, and now lives in Minot, North Dakota, with his wife and three children, all of whom attended Monday's ceremony. Obama joked how Romesha's youngest child had run around the Oval Office, sampling apples.

"We're so glad that you're here, along with your three beautiful children – Dessi, Gwen and Colin," Obama said. "Colin is not as shy as Clint. He was in the Oval Office, and he was racing around pretty good and sampled a number of the apples before he found the one that was just right."

Now involved with oil field safety, Romesha was a troop section leader in the 4th Brigade Combat Team of the 4th Infantry Division when the Taliban attacked his Combat Outpost Keating in an area near the Pakistan border beginning at 6 a.m. Oct. 3, 2009.

"Combat Outpost Keating was a collection of buildings of concrete and plywood with trenches and sandbags," Obama said. "Of all the outposts in Afghanistan, Keating was among the most remote. It sat at the bottom of a steep valley, surrounded by mountains – terrain that a later investigation said gave 'ideal' cover for insurgents to attack. COP Keating, the investigation found, was 'tactically indefensible.' But that's what these soldiers were asked to do – defend the indefensible.

"These men were outnumbered, outgunned and almost overrun," the president said during the ceremony, adding: "Our troops should never, ever, be put in a position where they have to defend the indefensible."

Eight of the 53 U.S. soldiers at the out-

post were killed in the firefight. Many in the audience were seen weeping as Obama read the names of the fallen. Twenty-two soldiers were wounded, including Romesha, who received shrapnel from a rocketpropelled grenade. At a news conference last month, Romesha dismissed his wounds.

"I've had buddies that have lost eyesight and lost limbs," Romesha said at that news conference, held after Obama notified the former soldier of his award. "I would rather give them all the credit they deserve for sacrificing so much. For me it was nothing, really. I got a little peppered, that was it."

Even though he was wounded, Romesha continued to kill enemy soldiers, recovered his fallen comrades and led operations for the counterattack, according to the account of the day's action. Officially, Romesha is credited with directly killing more than 10 enemy fighters, about 30 more with indirect fire and leading other U.S. troops to kill at least five more.

"His heroic actions allowed B Troop to reconsolidate on the combat outpost and enabled him to lead the counterattack that secured" the outpost, according to the Army's official narrative.

Romesha served two tours in Iraq as well as his time in Afghanistan. He left the Army in 2011.

In his book, "The Outpost: An Untold Story of American Valor," CNN anchor Jake Tapper described the battle.

"Everything was just about his buddies and trying to save his fellow soldiers and trying to do everything he could, literally everything he could, at great risk to his own life over and over," Tapper told the *Associated Press*. "He's still very broken up about how he couldn't save everyone. He saved lives that day, without question, but eight of the guys died that day and that still tears him up."

Obama described the fight as "one of the most intense battles of the entire war in Afghanistan."

"And if you seek a measure of that day," he said later in the ceremony of those who fought, "you need to look no further than the medals and ribbons that grace their chests – for their sustained heroism, 37 Army Commendation Medals; for their wounds, 27 Purple Hearts; for their valor, 18 Bronze Stars; for their gallantry, nine Silver Stars."

The Resolutions Chairmen are the "Magic Wands" as they "wave" with thoughtful care over proposed changes in the procedure and policy of our organization in a way that will enhance Madam President's vision for the future of our great Department.

The Constitution, Bylaws, Standing Rules and Code are living documents and as such, are open to change. Any change must be accomplished by way of a systematic approach leading to a consensus of the general membership. Resolutions are a form of presenting recommendations for changes in policy or procedure. They should be concise and deal with only one subject. An attempt to deal with more than one subject is both complicated and confusing. If you are planning to submit a resolution to the Department Convention Body, keep it simple. Before you start, ask yourself the following questions: Will this action be feasible? Will it benefit the entire membership or just a few? Is it affordable? If your answers are yes, then by all means, submit your resolution.

There are two parts to a resolution. The Preamble, which consists of the "Whereas" Clause, comes first. In deciding how many "Whereas" Clauses a resolution should have – in general – the fewer you have, the better. The Resolve Clause is the intent or simply put, it states what you want to accomplish by this change.

Resolutions must be typed on the official form, in triplicate, double-spaced and signed before they are sent to the Department Office. Please do not mail resolutions to me. Strict deadline dates must be adhered to: April 9, 2013 for resolutions pertaining to the Constitution/ Bylaws; April 24 for finance; May 9, 2013 for other matters. Exact details and further information can be found in the Department Constitution, Article IV, Section 4. A form and information will also be mailed out by the Department Office.

The Annual Convention, to be held at Palm Springs, California on June 27-30, 2013, is hereby called for the officers for the ensuing

purpose of electing officers for the ensuing year, amending Department Constitution and Bylaws, receiving reports of Department Officers, Chairmen and their committees and for the transaction of other such business as may be brought before the delegate body.

**Representation** – The annual Convention shall be composed of regularly elected and appointed Department Officers, District Presidents, Past Department Presidents in good standing in their respective Units, chairmen of Department committees, members of the Department Finance Committee, Girls State Director, Junior Conference Director, Hospital Representatives and regularly elected delegates and alternates from each Unit. Each Unit shall be entitled to two (2) delegates and two (2) alternates for charter and one (1) additional delegate and one (1) alternate for each seventyfive (75) members or major fraction thereof, paid up in Department Headquarters forty-five (45) days prior to the opening of Department Convention. The vote of each Unit shall be equal to the total number of delegates to which the Unit is entitled, provided full registration fee has been paid for such delegates at the call of the Department Secretary/Treasurer prior to pre-Convention caucus (Article IV, Section 2. Department Constitution).

Delegates in Their Own Right-Department Officers (President, Vice President, Secretary/ Treasurer, Chaplain, Historian, Parliamentarian, Sergeant-at-Arms, Marshal, Musician), District Presidents, Past Department Presidents in Good Standing in Their Respective Units, Chairmen of Department Committees (Americanism, Auxiliary Emergency Fund, Children and Youth, Community Service, Constitution and Bylaws, Convention Commission, Editor, Education, Girls State, Junior Activities, Leadership, Legislative, Membership, Music, National Security, Past Presidents Parley, Poppy, Public Relations, Veterans Affairs and Rehabilitation), Members of the Department Finance Committee, Girls State Director, Junior Conference Director, Hospital Representatives, Appointed Chairmen (Advisory Committee, Distinguished Guest, Resolutions, Elections, Rules, Credentials, Ways and Means).

# DELEGATES AND ALTERNATES MUST BE ELECTED – They cannot be appointed!

Registration Fee – All Units in good standing shall pay a registration fee not to exceed twenty dollars (\$20.00) per delegate. Fee shall cover full voting strength of the Unit prior to the District pre-Convention caucus. (Article IX, Section 3. Department Constitution) The fee is due whether or not the delegates and alternates attend Convention. Indebtedness-No delegate or delegates from any Unit shall be seated in Department Convention or pre-Convention caucus unless all obligations to Department

shall have been paid or satisfied (Article IV, Section 2. Department Constitution). Indebtedness includes Fidelity Bond, purchase of Poppies, ten percent (10%) net proceeds from Poppy donations, filing of Poppy Financial Report and delegate/alternate fees.

Credential Cards – Upon receipt of the registration fee of \$20.00 per delegate (including those accorded voice and vote in their own right) with the certification form of delegates and alternates, the Department Secretary/ Treasurer will issue credential cards. The Credential cards will be available at the registration desk and will be signed by the Department Secretary only.

Alternates Serving in Place of Delegates – A delegate or alternate cannot be seated on the Convention floor unless her name appears on the Certification Form of Delegates and Alternates for the Unit. Regular credentials will be issued ONLY to those properly certified as delegates or alternates.

- 1. Those alternates serving in place of delegates who will not be attending Convention will then be registered as delegates upon presentation of credentials and be listed with the voting delegation.
- 2. All other alternates will receive credentials and shall be called in by the Unit Delegation Chairman of the delegation during a temporary absence of a regular delegate, provided the delegate has turned in her badge to the Unit Delegation Chairman or District President for the alternate to wear. When possible, it shall be the duty of each Unit Delegation Chairman and/or District President to see that a full voting delegation is present.
- 3. A delegate leaving the Convention not to return shall relinquish her badge to the District President if an alternate from the same Unit is available to serve. It shall be the duty of the District President to call in any available alternate from said Unit and to supply her with the badge of a delegate who has left the Convention. **Resolutions:**
- 1. According to Article IV, Section 4, a copy of amendments pertaining to the Constitution and Bylaws is to be in Department Office not later than seventy-five (75) days prior to the opening of the following Depart-

ment Convention. Triplicate copies required

if via regular mail (Due April 13, 2013).

- 2. Resolutions pertaining to finance to be in the Department Office not later than sixty (60) days prior to the opening of the following Department Convention (Due April 28, 2013) Article IV, Section 4A.
- 3. All resolutions other than the above must be in the Department Office forty-five (45) days prior to the following Department Convention (due May 13, 2013). Exceptions to this may be made to allow the presenting of emergency resolutions no later than noon of the second day of Convention (Article IV, Section 4B). **Note:** Emergency resolutions are those which arise during the Convention or after the date established for admitting them (Article IV, Section 4C).

#### **CREDENTIALS**

Time is passing quickly, and Department Convention will be upon us before we know it. Here are a few "reminders" to give you a head up about Delegates and Alternates who will be attending.

Delegates and Alternates are "Elected", and CANNOT be "Appointed". In addition to your elected Delegates and Alternates, you MAY have Delegates in their "Own Right" in your Units. Be sure to read all the information sent out from Department to know who is eligible to be a Delegate in her own right. List your elected Delegates and Alternates, along with those in their own right, on the Certification Form that is returned to Department. Delegate Fees must be paid, whether or not they are attending Convention. You will not be seated if these fees are not paid.

Each Unit is entitled to Two Delegates and Two Alternates for Charter, and

one additional Delegate and Alternate for each 75 members or major fraction thereof, paid into Department Headquarters 45 days prior to the opening of Convention. # New Film: VA "Betrays" **Homeless Vets**

"Duty, Honor, Country BETRAYAL" is the title of a new documentary film, now available on DVD, dramatically exposing how the VA is failing homeless vets by giving away land donated solely to assist veterans to wealthy, politically-connected non-veteran interests through the VA's so-called "Enhanced Use Leases."

The focus of the documentary by Bill Dumas Productions is the National Veterans Home in West Los Angeles. But the problem of the VA's give-away of veterans' land to benefit non-veteran, politically-connected interests is nationwide.

Bill Dumas, an award-winning documentary film maker, said he focused on the National Veterans Home in L.A. because "it provides stark evidence that land that was donated to the government for the sole purpose of assisting veterans is instead being turned over to wealthy interests in give-away Enhanced Use Agreements while the VA locks out homeless veterans from that land."

L.A. is estimated to have some 20,000 homeless vets, the highest of any city. The National Veterans Home was established on a large tract of land, some 400 acres, which was donated to the government by two families in 1888 for the sole purpose of aiding veterans in need of medical and other services.

Instead, many of the wealthy residents and interests of Brentwood and other communities of the ultra-rich who are politically connected to Democrat Rep. Henry Waxman and the so-called "Westside Machine" now have control of many acres of the National Veterans Home through Enhanced Use Leases.

These leases are for as long as 75 years, at prices far below market value, often nominal payments of "\$1 a year," sometimes nothing at all.

Worst of all: The Secretary of Veterans Affairs has the authority to give that land to the lessees entirely in the Secretary's sole discretion, without Congressional action, if the Secretary decides the land is no longer needed for veterans.

An exemplar of this exploitation of veterans lands by the rich and infamous is ultra-rich Brentwood, which adjoins the National Veterans Home. Among other things, some of its very wealthy residents who really don't want homeless veterans out, about and visible in their neighborhood, created the misleadingly named "Veterans (sic) Park Conservancy" (which is not, in fact, a veterans organization), to grab veterans' land for their purposes.

The non-veteran, wealthy, politically connected (to Henry Waxman, et al) Brentwoodites have obtained a lease of "16-acres" for "zero" payments, for "ten years" with option to renew at the same price (nothing) for an additional ten years, in order to establish a "park." The VPC boasted in its press release sealing the deal with VA brokered by Waxman and political cohorts will "benefit veterans and the general public."

That is, the VPC will establish a public or semi-public "park" on land donated for the "sole" purpose of assisting veterans in need of medical, mental and emotional care and assistance, including housing.

Meanwhile, homeless veterans are locked outside the gates of their "National Veterans Home." Many large dormitory-like buildings on the land which could be used for the homeless, are empty, unused, deteriorating because the VA refuses to maintain them or build adequate new housing, or use the available land for temporary housing as new housing is built, as shown in the Bill Dumas documentary film.

The VA, with great fanfare praising itself, announced it would start a \$20 million building project, which is but a public relations gesture as it is woefully less than needed.

Similarly, the ACLU, also with great fanfare praising itself, shortly after the U.S. Supreme Court ruled against the ACLU in its ten-year long litigation to destroy the Moiave Desert Veterans Memorial Cross (Buono vs. Salazar), filed a face-saving lawsuit against the VA at the National Veterans Home in L.A. However, of the six major claims of its lawsuit, the court has dismissed five, and all that remains is one claim that the VA's policies violate the Administrative Procedure Act, the documentary notes.

Thus, it appears that if veterans' lands are going to be saved from the VA and politicians like Henry Waxman, it is going to take veterans actively fighting to save those lands.

The Department of California, following exposure of the Brentwood "park" give-away lease at the National Veterans Home, adopted at the 2009 Convention a resolution written by me and sponsored by District 21 which established a policy opposing the Brentwood VPC "park", and all VA land-use policies in which the land is not used "solely" to serve the needs of veterans, including housing.

At the 2010 Convention, the Department adopted a resolution written by Larry Van Kuran and sponsored by District 20 establishing a policy opposing the VA's land and facilities give-away policies at the VA's former medical center in Sepulveda, and opposing the VA's Extended Use Lease policies nationally. That resolution was adopted at the National Convention, as well.

"I made 'Duty, Honor, Country BETRAYAL' because I believe that the VA's policies are a betrayal of veterans and a national disgrace," said Dumas. "I hope it will help the cause of defending veterans who defended the nation, but who now find themselves homeless and locked out of land and facilities intended for their exclusive use and benefit."

# A Quick "Heads-Up" on Disaster Planning

I am sure that you are all aware that 2012-2013 is the year that the California Department is putting a great deal of emphasis on getting our disaster planning and preparedness in order. The Disaster Commission has started the process by providing each Area Commander and Adjutant with a pre-prepared Disaster Plan that can be easily edited to meet the needs of the Area, then printed out and adopted. The target date to get this stage completed is March 30, 2013. Area 1 has adopted theirs. If you do not have the plan in the works, please contact your Area Disaster Commissioner for immediate assistance.

The second stage of the project is to get all Calegion Districts to adopt a Disaster Preparedness Plan by March 30, as well. To make the process as easy as possible, a customized draft plan has been prepared for each District and has been provided to your Area Disaster Commissioner for forwarding to the individual Districts. It is requested that you contact each of your District Commanders to confirm they have received their draft plan and that it is in process of being adopted.

While these two phases are underway, the final draft of a new Calegion Department Disaster Preparedness and Response Plan has now been finished. The Department Commander has reviewed it and authorized it to be presented for adoption at the next DEC meeting in March.

Once the Department, Areas and Districts have adopted plans in place, each Post will be provided a draft "edit and fill in the blanks" plan for them to adopt for their Post. The target to get Post plans adopted is December 2013.

Starting in June, disaster training will begin to be provided in several formats, including a PowerPoint slide show, newsletter articles, downloadable lists and guidelines, links to free online FEMA training courses and so forth.

The American Legion in California has a great deal of work to do over the next two to three years to be prepared when the next disaster strikes. Planning, preparation and training are all necessary components of being ready to protect ourselves and to respond to help our friends, neighbors and communities.

I would appreciate you downloading the Plan, get familiar with it and then work with your District Commanders to get their plans adopted as soon as practical.
